As of the most recent prospectus, the net expense ratio for Advisor shares was 1.27% and for Investor shares was 1.12% and was applicable to investors. The investment adviser has contractually agreed to waive its advisory fees and/or reimburse expenses of the Active Dividend Fund, at least until March 31, 2020, so that the Total Annual Fund Operating Expenses (exclusive of front-end or contingent deferred loads; brokerage fees and commissions; acquired fund fees and expenses; borrowing costs (such as interest and dividend expense on securities sold short); payments, if any, under a Rule 12b-1 Distribution Plan; expenses paid with securities lending expense offset credits; taxes; and extraordinary expenses (such as litigation)) do not exceed 0.99% of average daily net assets for each of the Advisor Class, Investor Class and Institutional Class shares.

## FUND DESCRIPTION

The investment objective of Horizon's Active Dividend Fund is capital appreciation and current income.

The fund's investment adviser, Horizon Investments, seeks to achieve the investment objective by investing primarily in the equity securities of U.S. and foreign dividend paying companies.

## ASPECTS OF THIS ACTIVE FUND

The Active Dividend Fund employs a fundamental bottom-up process to identify companies that Horizon believes have one or more of the following characteristics:

- Dividend-paying;
- Favorable long-term fundamental characteristics;
- Priced below what Horizon believes to be the Company's intrinsic value;
- Projected ability to grow intrinsic value per share over the long-term.
